## The Tokyo War Crimes Tribunal

Professor of Criminal Law, International Criminal Law and Transnational Criminal Law, University of Canterbury, New Zealand

**Professor Neil Boister**, B.A., LL.B., LL.M. (Natal), Ph.D. (Nottingham), teaches Criminal Law, International Criminal Law and Transnational Criminal Law at the University of Canterbury in Christchurch, New Zealand.

He has taught in a number of different common law and mixed jurisdictions and written extensively on criminal law, international criminal law and transnational criminal law.

In regard to the Tokyo War Crimes Tribunal, he is the author of *The Tokyo International Military Tribunal, A Reappraisal* (Oxford: OUP, 2008; Japanese translation Tokyo: Kodansha, 2012) and *Documents on the Tokyo International Military Tribunal* (both together with Professor Cryer). He is also the author of 'Punishing Japan's "Opium War-making" in China: The Relationship between Transnational Crime and Aggression at the Tokyo Tribunal' in Yuri Tanaka, Tim McCormack and Gerry Simpson (eds), *Beyond Victor's Justice? The Tokyo War Crimes Trial Revisited* (Leiden and Boston: Nijhoff, 2011).

His other main research interest is in transnational criminal law and he works as a consultant for NGOs operating in this area. His book, entitled *An Introduction to Transnational Criminal Law* has just been published by OUP.
